Dear Councilmembers,

On behalf of the Master Builders Association of King and Snohomish Counties I am writing to encourage your support of Ordinance 22-014.

Lack of housing supply, especially for middle- and lower-income families in Snohomish County is at a crisis point. The most recent data from the Northwest Multiple Listing Service indicates there is on a .42-month supply of available housing. That is less than two weeks' worth. Contrast that with a six-month supply that would constitute a healthy number and it is easy to see why we are in a housing crisis.

The median price of that housing is also at a record \$758,707.

Ordinance 22-014 puts more tools in the toolbelt for offering more families housing. Increased density, modest height allowance and preservation of existing housing stock will help alleviate our extreme housing shortage.

The housing envisioned in the ordinance is in urban areas and is well within the spirit and intent of the Growth Management Act – encouraging urban density.

**Background:** This ordinance addresses regulations for housing in urban zones. It makes several changes in Title 30 SCC to encourage more "missing middle" density housing and includes incentives to preserve existing units instead of demolishing them during new development.

### A summary of the proposed ordinance is as follows:

Reference notes 4 and 5 are amended to grant density bonuses for new development projects that retain existing units on or that relocate existing units to sites with LMDR and MR zoning, respectively. Reference Note 65 is amended to increase the density bonus for townhomes in the R-7,200 zone to 50% from

20% and to grant a further density bonus for retaining or relocating existing units. Reference note 67 is added to provide a cross reference to SCC 30.23.310, the proposed new section that addresses exceptions to the new larger setbacks for buildings taller than 30 feet in the R-7,200 zone.

<u>Section 7</u>. Amends SCC 30.23.210 to give a density bonus for lot size averaging developments in the R-9,600, R-8,400 and R-7,200 zones that retain existing units on or relocate existing units to the project site.

<u>Section 8</u>. Adds a new section SCC 30.23.310 to address exceptions to the new larger setbacks for buildings taller than 30 feet in the R-7,200 zone.

<u>Section 9</u>. Amends SCC 30.42B.040 to increase the density bonus for most Planned Residential Development (PRD) to 50% from 20%. It also amends the section to grant density bonuses for projects that retain existing units on or that relocate existing units to a PRD site.

Section 10. Provides the effective date for the ordinance.

Section 11. Provides a standard severability and savings clause.

This ordinance encourages efficient use of the land supply by 27 giving larger density bonuses to innovative housing types. 28 29 2. Housing Policy HO 2.B: "Encourage the use of innovative urban design 30 techniques and development standards to foster broad community acceptance of 31 a variety of housing types affordable to all economic segments of the population." 32 This ordinance encourages two types of housing that already have design 33 34 requirements to ensure compatibility and acceptance. It also encourages 35 retention of existing housing stock, which is generally more affordable, on sites experiencing new development, thereby promoting a broader range of housing 36 types and affordability than would likely otherwise exist at the same location. 37 38 3. Housing Policy HO 3.B.5: "The county shall continue the demonstration program 39 that provides for the use of environmentally sensitive housing development 40 41 practices that minimize the impacts of growth on the county's natural resource systems without adding to the cost of housing." This ordinance encourages the 42 preservation of existing housing units rather than redeveloping, which is more 43 44 environmentally sensitive than demolition. 45

4. Land Use Policy LU 4.A.1: "The county shall work with architects, builders, and 1 2 others to ensure that the design review process, innovative and flexible 3 standards, and development regulations for site planning and the design of 4 buildings are consistent with the urban design policies of the GPP." This ordinance provides flexibility with integrating existing buildings with new 5 6 development, while maintaining urban design requirements. 7 8 5. Land Use Policy LU 4.A.2: "The county shall ensure that design standards for 9 residential, commercial, and industrial development meet the following criteria: 10 Subsection (b) Where increased density housing is proposed, the height, scale, 11 design and architectural character should be compatible with the character of the 12 13 buildings in the surrounding area. 14 . . . Subsection (f) Developments should provide adequate setbacks, buffers and 15 visual screens to make them compatible with abutting residential and other land 16 17 uses." This ordinance ensures the design standards that promote compatibility with the 18 surrounding area are maintained through continuing application of the design 19 standards in chapters 30.23A and 30.42B for any new development allowed 20 under this ordinance. In addition, this ordinance promotes compatibility with 21 buildings in the surrounding area by encouraging the preservation of existing 22 23 housing stock and imposing additional setback requirements for townhome 24 development when heights are increased. 25 26 F. Procedural requirements. 27 28 1. The proposal is a Type 3 legislative action pursuant to SCC 30.73.010. 29 30 2. The public participation process used in the adoption of this ordinance has complied with all applicable requirements of the GMA and the SCC. 40 41 42 5. 
