5. Ordinance 24-011, annual testing of county-owned housing facilities for contamination from hazardous chemicals

Chair Mead opened the public hearing.

Cynthia Foley, Legislative Analyst, provided a staff report and explained the first and second proposed substitute ordinances, as well as two amendments to the first proposed substitute ordinance.
