Clearview Cannabis Buffer - Economic Impact, Community Support, and Process Documentation

Purpose

This packet supports executive and administrative review of the Clearview cannabis retail buffer. It documents economic impacts, community support, correspondence, and lobbying activity relevant to the application of a unique 10,000-foot buffer in the Clearview corridor.

1. Economic impact graph showing annual and five-year cannabis tax revenue losses to Snohomish County.

Executive Synopsis – Clearview Review Packet

Thank you for taking the time to meet with me and to review this packet. I appreciate your willingness to look closely at the materials provided and to consider a practical path forward. The purpose of this packet is to present a clear, organized record of the economic impacts, community support, and process-related issues associated with the application of the 10,000-foot cannabis retail buffer in the Clearview corridor, and to support administrative review of whether corrective action is appropriate.

1. Economic Impact Summary

The packet includes a one-page graphical summary outlining the economic impact of the Clearview location remaining closed. This includes annual and five-year projections of lost cannabis tax revenue to Snohomish County, lost wages associated with 14 full-time jobs, and lost revenue to local cannabis vendors. These figures are consistent with information previously provided to County Council and are presented in a concise, easy-to-review format.

2. Clearview Business & Community Support

This packet contains a comprehensive list of Clearview-area businesses that have signed in support of opening the Clearview location, along with signatures from local residents and Snohomish County voters who frequent my existing retail locations. More than 90 percent of operating businesses in Clearview have either expressed support or indicated that they are not opposed to the location. Where available, contact information is included, and signatories have indicated a willingness to be contacted for verification.

3. Public Correspondence Analysis

Included is a breakdown of public correspondence provided by Councilmember Sam Low, reflecting a review of more than 500 emails submitted regarding the Clearview buffer. This analysis shows that a significant portion of the correspondence originated from a small number of individuals, providing context regarding the scope and diversity of public input considered during the process.

4. Vendor Communications

The packet includes an email communication sent to cannabis vendors discouraging them from doing business with Hangar 420. This document is included to illustrate the downstream impacts of the current situation on Snohomish County producers and processors, and the competitive pressures that can arise when market access is restricted.

5. Lobbying & Code Development Correspondence

Also included is email correspondence between county staff and a registered lobbyist discussing code concepts related to the Clearview buffer. These materials are provided to


document the nature and scope of stakeholder engagement during the 2023 process.

6. Lobbying Expenditure Timeline

Finally, the packet includes a timeline summarizing lobbying expenditures reported through public disclosure filings. The timeline shows an increase in lobbying activity during the period when a license relocation and buffer change were being pursued, continued activity during implementation, and a decline in expenditures following completion of that process. This information is included to provide context regarding the timing and scale of advocacy efforts relative to the policy outcome, and to support a transparent, fact-based administrative review.

I appreciate your time and consideration in reviewing these materials. My goal is to resolve this matter as efficiently as possible, restore consistency with countywide standards, and allow this location to open, hire local employees, and begin contributing to the community and tax base. I look forward to working collaboratively toward a practical and timely solution.

Hi Josh,

I am attaching the latest version of the ordinance to allow marijuana retail in CRC zoning. This addresses the concern raised by others that you and I previously discussed by creating a new 10,000 foot separation requirement for rural zones. The current 2,500 foot requirement would remain for urban zones. By making a 10,000 foot separation applicable to rural zones, it would apply equally to both CRC and RB zoning.

By my measurements:

- 8270 feet (1.57 miles) would span both CRC nodes, fulfilling an objective of the ordinance
- 9170 feet (1.75 miles) is the distance between the closest nodes of zoning that contain two legally permitted marijuana retail locations in rural areas
- 10,790 feet (2.05 miles) is the distance between the physical location of the closest two stores in the nodes above (The Kushery and Euphorium)

The proposed **10,000-foot separation** is an easy round number that would not likely raise questions on how it was determined. As a practical effect, this would limit the **Kushery** from moving to the southern-most parcels with CRC zoning since they would be too close to Euphorium, but moving to the vast majority of parcels with CRC zoning would be possible.


