WHEREAS, prior to its integration into Snohomish County, the Snohomish Health District entered into a program agreement with Washington State Department of Social and Health Services to assist recipients of Temporary Assistance for Needy Families (TANF) to meet their goals and provide well-being for their family through the WorkFirst Program; and

WHEREAS, the Washington State Department of Social and Health Services and the Snohomish County Health Department wish to continue this partnership; and
