1. Ordinance 22-030, approving Common Interest, Non-Disclosure and Joint Defense Agreement with Snohomish Health District

Heidi Beazizo, Senior Legislative Analyst, provided a staff report to explain the scope of the agreement relating to the open sharing of information in the integration process of the County's plans to withdraw from the Snohomish Health District and establish a county health department.
