1. Ordinance 22-030, approving Common Interest, Non-Disclosure and Joint Defense Agreement with Snohomish Health District [2022-0752](#)

Council Chair Dunn opened the hearing and the clerk read the ordinance title into the record.

Heidi Beazizo, Senior Legislative Analyst, provided a staff report to explain the scope of the agreement relating to the open sharing of information in the integration process of the County's plans to withdraw from the Snohomish Health District and establish a county health department.

Council Chair Dunn thanked the integration team for their work in moving forward with plans and working with all the stakeholders.

Council Chair Dunn opened the hearing for public testimony. There being no persons present wishing to testify, she closed the testimony portion of the hearing calling for a motion or discussion of the Council.

2. Ordinance 22-028, relating to the Growth Management Act, [2022-0665](#)  
adopting technical amendments to the Snohomish County Growth Management Act Comprehensive Plan and Title 10 Snohomish County Code (GPP 22-3 -Technical Corrections)

Ryan Countryman, Senior Legislative Analyst, provided a brief recap and explained that the preference is to coincide the evening public hearing with an evening district meeting.
