<u>Authority Granted</u>: Motion 24-271 authorizes the County Executive to execute a professional services agreement with DZPA through June 30, 2025.

**Background:** Snohomish County contracted with Erin Dziedzic of DZPA from January through March of 2024, for a monthly fee of \$6,000 for lobbying services. The contract not to exceed amount was \$18,000.

On May 22, 2024, Council passed Motion 24-194<sup>1</sup>, approving Amendment No. 1 to a contract with Gordon Thomas Honeywell for lobbying services. The amended contract increased by \$125,008, bringing the contract total to \$360,024. The contract with Gordon Thomas Honeywell expires on July 31, 2025.

**<u>Requested Action</u>**: Move to GLS for Council consideration.
