I helped with the local mask drive initiative to sew and distribute masks to local facilities. I launched the Stay Artistic Program to introduce and promote local talents and embrace future little artists. I got a grant from the City of Redmond. I got another grant from 4Cultures for Art and Culture Festival 2021 I hosted at the Muslim Association of Puget Sound. I grew audience, our FB following increased from 300 followers to 2800 followers. I created a blog, YouTube channel with entertaining content and huge traffic and community engagement. As a member at the Ethnic Studies Committee at NSD, I pushed for including the Arabic Language to be listed among languages to be taught as a second language in the dual language program.
