**Subject:** Corrections – Contract with Reassurance Solutions, LLC – Medical Monitoring Devices

**Scope:** Motion 26-025 would approve the County's first contract with Reassurance Solutions, LLC for the acquisition, installation, and maintenance of medical monitoring devices. Under the contract the following will be installed and fully functioning within 60 days of the effective date:

- 16 Medical Sensors (XK300)

*These are the devices that will physically be mounted in the cells. They will be mounted using tamper proof screws and tear-resistant caulking to help avoid damage to the device.*

- 8 Gateway

*This is kind of like the connecting hub the sensors go into. At least per gateway, they may be able to use less but won't know until installation. If less is used it will decrease initial cost by \$500/each gateway.*

- 16 Subscriptions

*These are annual and tied to each device. This subscription is how the devices get their software updates.*

**Background:** The 2025-2026 Budget included funding for a health monitoring system in the Snohomish County Jail. The Executive's recommendation was for this to be a pilot

program, tested in 2025 with the decision whether to continue being made later. Funding provided was \$50k in 2025 and \$50k in 2026 from Fund 124 (CDMH) under Change Request #73. The change request noted purchasing 50 smart type watches designed to monitor individuals' vitals.

Through RFP 25-0410JM-C, [Reassurance Solutions](#) was selected as the company to provide this service. Since budget adoption, the type of device has changed from a smart watch to 16 units that are mounted on the ceiling of the cell called the XK300 sensor. This device monitors heart rate and breathing vitals and provides real-time alerts for inmates in medical distress to allow for faster response to medical emergencies.<sup>1</sup>
