Attached is a PDF of Ordinance 23-053, granting a non-exclusive franchise authorizing limited use of the public road rights-of-way in portions of Unincorporated Snohomish County, Washington to Snohomish School District No. 201, approved by the County Council on July 12, 2023.

Please sign the acceptance page (PAGE 31 of the Ordinance) and email the signed page back to our office. Pursuant to Section 32 of the Ordinance (p. 29), the Grantee has **90 days** after approval by the County Council (**October 10, 2023**) to accept the agreement.

Following receipt of the acceptance page by the County Council, and payment of all administrative costs and applicable fees made with the County Public Works Department, the Franchise will be recorded with the County Auditor's Office. See Section 33 of the Ordinance (p. 29) on the conditions for the franchise to take effect.
