Subject: Amending Snohomish County Code Section 7.41, relating to the solid waste

service fee schedule and additional charges for unsecured loads.

Scope:

The proposed Ordinance would amend the solid waste service fee schedule, updating tipping fees and establishing a separate fee schedule for waste export specific services starting January 1, 2026. The proposed base rates are recommended to increase annually by 3%, starting on January 1, 2027.

<u>Authority Granted:</u> The County Council adopts Ordinance 25-027, under Snohomish County Charter 2.100 and 2.110.

Background: According to Snohomish County Code, the solid waste fee schedule will be based on full cost recovery standards and the service fees for solid waste disposal shall be based upon measured weights whenever possible. Solid waste tipping fees at transfer stations and drop boxes were last adjusted in 2009. In 2022 Council approved Motion 22-494 establishing a minimum weight per container for the Residual Reclamation Waste program (RRW) and raised the fee on Vactor Waste from \$201 per Vactor truck load to \$315 per Vactor truck load. In 2023 Council approved Motion 23-390 revising the operating rules and increased the RRW rate from \$65 per ton to \$85 per ton. To assist with cleanup and disposal of household goods damaged by the Flood Event of December 2023, Council approved Motion 24-094 to provide for the elimination or reduction of solid waste disposal fees for declared emergencies. The Solid Waste Division (SWD) completed a Council approved (Motion 24-088) Cost of Service and Rate Analysis, which created a service and rate model to assist with cost forecasting. After reviewing the results of the analysis, it was determined that the adopted tipping fee schedule was no longer adequate, and a step approach was recommended for increasing the solid waste service fees.

In August 2024 Council approved Motion 24-325, adjusting the Residual Reclamation Waste, Vactor Waste, Moderate Risk Waste disposal and Illegal Dumping fees. The proposed ordinance would align the fee schedule, which includes adjusting the remaining tipping fees and adding a separate fee schedule for waste export specific services starting in 2026 and includes the addition of an annual 3% increase starting in 2027.

It has also been determined that the current fees associated with unsecured loads did not provide adequate funding for program enforcement and education. These fees are also proposed to be updated within the ordinance but are not to be included in the annual 3% increase. According to the results of the analysis model, without the proposed increase to the solid waste rate fee schedule in 2026 the SWD will not have enough fund balance or incoming revenue to continue operations.

<u>Action Requested:</u> For Council to move the ordinance to May 7th GLS set time and date for a Public Hearing, with the suggested date and time of May 28th, 2025, at 10:30 am.
