THIS AMENDMENT NO.1 to that certain Agreement for Professional Services (the “Agreement”) dated July 1, 2021, is made by and between Snohomish County, a political subdivision of the State of Washington (the “County”) and Parametrix, Inc., a Washington corporation (the “Consultant”).

Contract Maximum. Total charges under this Agreement, all fees and expenses included, shall not exceed \$175,000.00.

2. Schedule A-1, Scope of Work attached hereto and by this reference made part of the Agreement, has been added as additional work to be performed under Schedule A.
3. Except as expressly provided in this Amendment No. 3, all terms and conditions of the Agreement, shall remain in full force and effect.
