Costs for implementation for additional licenses and annual maintenance was included in the 2025-2026 Biennial IT Budget request. The cost to acquire the additional licensing is \$225,688.18 (plus sales tax) and the cost for maintenance is \$106,411.40 (plus sales tax) for the remainder of the contract.

<u>Authority Granted:</u> Approve and authorize the County Executive to execute Amendment 3 to the Technology Solution Contract between Snohomish County and Open Text, under SCC 3.04.140(8).

Background: In 2018, Snohomish County entered into a software license agreement and technology solution contract for professional services with Open Text Inc., per the Washington State Department of Enterprise Services Master Contract No.07814-002 and the Snohomish County Statement of Work, as a "Technology Solution Contract for an Enterprise Content Management Solution".

The provided technology solution software provides an electronic content management system (ECM) for Snohomish County Planning and Development Services (PDS). The current Open Text ECM platform allows for the implementation of software solutions to the PDS strategic technology plan, which includes streamlining the permitting process and improving the management of the millions of records maintained by PDS.
