APPROVING AND AUTHORIZING THE SNOHOMISH COUNTY EXECUTIVE TO SIGN THE INTERLOCAL AGREEMENT BETWEEN THE CITY OF MONROE AND SNOHOMISH COUNTY FOR JOINT OPERATION OF THE WINTER DOG PARK

Summary: The City of Monroe operates a dog park at Wiggly Field, however, during the winter, Wiggly Field often floods resulting in closure of the dog park. The ordinance approves an agreement to allow the City of Monroe and Snohomish County to jointly operate the Winder Dog Park at the Evergreen State Fair Park in the outdoor covered arena during the winter.

At the Public Hearing, the Council may consider amendments to the proposed ordinance.

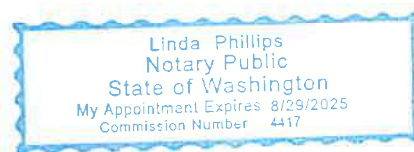


