Background

Engrossed Substitute Senate Bill 5092¹ included an appropriation of \$5,500,000 in fiscal years 2022 and 2023 to assist counties with public defense costs related to vacating the sentences of defendants whose convictions or sentences are affected by the State v. Blake decision.

On June 23, 2021, Office of Public Defense (OPD) signed an agreement for receipt of \$97,047 as allocated by the Washington State Office of Public Defense; also received was accompanying policy governing the permitted uses of the grant. Motion 21-285 (ECAF 2021-0640) has been submitted by OPD requesting council ratify the agreement which was requires council approval.

In order to utilize the grant funds, the Office of Public Defense requires an increase to their expenditure authority as these funds were not anticipated in the 2021 Adopted Budget.

PURPOSE: To make a supplemental appropriation in General Fund 002 to provide expenditure authority for funds received from the Washington State Office of Public Defense.

BACKGROUND: The Washington State Office of Public Defense notified the Snohmoish County Office of Public Defense that Snohmoish County had been selected to receive funds for representation of individuals on cases impacted by State v. Blake, 481 P. 3d 521 (2021). The Washington State Supreme Court announced its opinion in State v. Blake that all previous convictions for simple drug possession were unconstitutional. Any person with a conviction for simple possession has a right to have the unconstitutional conviction vacated from their record. This supplemental appropriation is necessary to provide expenditure authority for the funds received.
