

**AMENDMENT 3 TO THE SOFTWARE LICENSE AND SERVICES AGREEMENT
RELATING TO AUTOMATED CASHIERING SYSTEM**

This Amendment 3 to the Software License and Services Agreement Relating to Automated Cashiering System (“Amendment 3”) is entered into as of this 29th day of June, 2023, by and between Snohomish County, a political subdivision of the State of Washington (hereafter “the County”) and N. Harris Computer Corporation d/b/a Systems Innovators, a division of N. Harris Computer Corporation, a Canadian corporation whose address is 1 Antares Drive, Suite 400, Ottawa, Ontario, Canada K2E8C4, (hereafter “the Contractor”).

RECITALS

WHEREAS, the County and Contractor are the parties to that certain “Software License and Services Agreement Relating to Automated Cashiering System” executed on January 19, 2010, and amended on January 7, 2020 and December 7, 2020 (the “Agreement”); and

WHEREAS, the current term of the Agreement will end on January 18, 2024; and

WHEREAS, the County desires to continue to receive software maintenance and support for the automated cashiering system; and

WHEREAS, the parties have agreed to extend the Agreement for five (5) years through January 18, 2029; and

WHEREAS, the total cost of this Amendment 3 from January 19, 2024 through January 18, 2029, is Forty-One Thousand Seven Hundred Twenty-Seven Dollars and Seventy-Nine Cents (\$41,727.79).

AGREEMENT

NOW, THEREFORE, in consideration of the covenants hereinafter set forth and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the County and Contractor agree as follows:

1. Section 5. Term of Agreement, shall be amended to add a new subsection 5.1.7 that shall read as follows:

5.1.7 Term of Agreement shall be extended for one additional five-year term through January 18, 2029.

2. Section 7. Price and Payment Subsection 7.7 shall be amended to read as follows:



7.7 Maintenance and Support fees for the period of:

- a) January 19, 2021 through January 18, 2022 shall be \$7,051.06 plus applicable sales tax, and

- b) January 19, 2022 through January 18, 2023 shall be \$7,051.06 plus applicable sales tax, and
- c) January 19, 2023 through January 18, 2024 shall be \$7,192.08 plus applicable sales tax, and
- d. January 19, 2024 through January 18, 2025 shall be \$7,551.68 plus applicable sales tax, and
- e. January 19, 2025 through January 18, 2026 shall be \$7,929.26 plus applicable sales tax, and
- f. January 19, 2026 through January 18, 2027 shall be \$8,325.73 plus applicable sales tax, and
- g. January 19, 2027 through January 18, 2028 shall be \$8,742.01 plus applicable sales tax, and
- h. January 19, 2028 through January 18, 2029 shall be \$9,179.11 plus applicable sales tax.

3. Except as expressly provided in this Amendment 3, all terms and conditions of the Master Agreement, as amended, remain in full force and effect.
