Now, Therefore, The Condition of the Above Obligation is Such, that if the above bounden

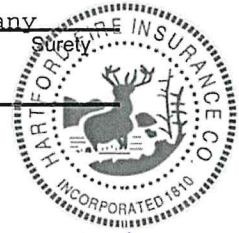
Jason Cummings shall, during the aforesaid term, faithfully and truly perform all the duties of their office and shall pay over and account for all funds coming into their hands by virtue of

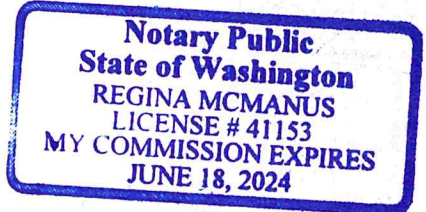
