**Subject:** Wa State Department of Commerce Grant for LGBTQIA Youth Support

**Scope:** A grant of \$593,750 is being provided to the Department of Human Services for LGBTQIA Youth Support. The grant contract scope of work stipulates that Snohomish County Human Services will contract with the Community Foundation of Snohomish County to support capacity building activities for GLOBE, an organization for supporting LGBTQIA+ youth, parents, and families, with school-based collaboration and social activities.

Reimbursable activities include:

- Community Foundation Support with creating policies, procedures, and capacity-building.
- Technical assistance/training for LGBTQIA+ support groups in community or school-based events.
- Fiscal software to support capacity-building at GLOBE.
- Support youth, parents, and families through school-based collaboration.
- Expenditures for travel, fundraising, and purchase of assets may be allowable with confirmation from Department of Commerce.
- One-time client stipends for education costs and enrollment fees.

This grant was not included in the grant work plan and requires Council approval.

**Background:** In 2024 the Washington State Legislature amended Commerce’s budget to appropriate \$625,000 of the general fund state appropriation to Snohomish County Human Services to provide technical assistance and contract with a nonprofit to support youth, parents, and families with school-based collaboration, and social activities for youth.

GLOBE’s mission is “to make Snohomish County a safe and nurturing community for LGBTQIA+ youth by enhancing the physical, emotional, sexual, and spiritual well-being of youth, providing positive interaction with adult role models, providing community education, and developing resources for and about LGBTQIA+ youth.”
