### **Consideration:**

The proposed motion would authorize the County Executive to execute a consent to the assumption for the software license agreement for permit tracking software system (AMANDA), per SCC 3.04.140(8).

### **Background:**

In 1994, Snohomish County entered into a software agreement with Sequent Computer Systems Incorporated, after being chosen as the successful bid winner for RFP 06-13, following all Federal, State and County policies, to provide the County with hardware and permitting software to be installed, implemented, and supported. This software, known as AMANDA, tracks all Planning and Development Services (PDS) permits, in conjunction with Public Works permits, and all related permit fees. AMANDA is a critical software needed for the continued business operations of PDS. The system was upgraded and enhanced in 1998, 2001, 2007, 2009, 2012, and 2018 (Amendment 7 to the Software License Agreement, Motion 18-214)<sup>1</sup>.

The AMANDA product was purchased from CSDC Systems, Inc. as successor in interest to Sequent Computer Systems Incorporated. In 2019, CSDC was rebranded and became known as Calytera US, Inc. In 2020, Calytera was acquired by Granicus, who in-turn is requesting the assumption of the previously agreed to software license agreement for AMANDA.

### **Current Proposal:**

*Scope:* The proposed Consent to Assumption of Software License Agreement for Permit Tracking Software System (AMANDA) memorializes Granicus' desires to accept and assume all Calytera's rights, duties, benefits, and obligations under the previously executed Agreement.

*Duration:* The term of this amendment is from execution to November 30, 2023.

*Fiscal Implications:* The total amount payable under the Agreement is not altering, as Granicus desires to accept and assume all of Calytera's rights, duties, benefits, and obligations.

**2021 Budget:** Yes, the annual maintenance fee was anticipated and included within the adopted 2021 budget and is included in the approved 2022 budget.
