CSAC is comprised of between 12 to 24 members with representation from relevant stakeholder groups (community/private **Executive Rec:** sector, low-income representatives, and public elected officials). CSAC is responsible for engaging with the Snohomish County community to address needs and address causes of poverty. Additionally, CSAC oversees administration of the Community Services Block Grant (CSBG), a federal program that provides funds to "alleviate the causes and conditions of poverty and remove obstacles to self-sufficiency in communities."

CASA Mission "The Advisory Council's mission is to make Snohomish County more responsive to the needs and interests of the poor by mobilizing both government and nongovernment resources and creating greater institutional sensitivity through education and advocacy."<sup>2</sup>

Members commit to identifying needs from the Community Needs Assessment; an estimated three hours monthly for CSAC meetings, activities, and preparation; attending
