## Contract #: 2369-50009 Amendment 3

This Contract between the State of Washington Department of Social and Health Services (DSHS) and the Contractor is hereby amended as follows:

- A. Exhibit B-2, Budget, is revised and replaced by Exhibit B-3, approved line-item Budget, which is attached hereto and incorporated herein.
- B. Maximum Consideration is increased by \$105,326 [\$5,326 of state Senior Farmers Market Nutrition Program funding (\$4,826 for Administration, \$500 for Nutrition Education) and \$100,000 for Case Management/Nursing Services (Core Services)] for a new maximum consideration of \$16,832,416.

All other terms and conditions of this Contract remain in full force and effect.
