<u>Authority Granted</u>: Approve and authorize the County Executive to execute Amendment 2 to the Agreement for Professional Services for Cayenta Upgrade, under SCC 3.04.140(11).

Background: In 1996 the County selected Cayenta Canada Corporation, formerly SFG Technologies, Inc., through RFP-01-95 to install and implement an enterprise integrated financial management software system. The hardware that supports this application reached its end of life in October 2023, and the County required assistance in upgrading the database platform.

The County published Sole Source SS-002-21 and Sole Source SS-004-021BC, with only N. Harris responding. A Professional Services Agreement was executed in September 2021, with an amendment in 2023 for additional professional service needs. Multiple change orders have been required, as various modules were either descoped and applied to new features, or different support needs were identified through the upgrade process.
