

Noise & Operations Monitoring System (NOMS) Contract Between Exelis Inc., a Wholly Owned Subsidiary of Harris Corporation, and Snohomish County

Change Order 001

THIS Change Order made as of the date last signed (hereinafter "Execution Date"), between Exelis Inc., a wholly owned subsidiary of Harris Corporation, having a place of business at 12390 Worldgate Drive, Herndon, Virginia 20170, (hereinafter "Exelis") and Snohomish County, having a place of business at 3220 100th Street SW, Everett, WA 98204.

WHEREAS, Exelis and Snohomish County entered into Contract No. 075-13 entitled Noise & Operations Monitoring System (NOMS) for services, of which the contract period of performance is 11/1/2013 – 10/31/2018;

WHEREAS, in Contract No. 075-13 Exelis proposed Schedule II – Option for a Flight Tracking Web-based Public Access Use Portal:

WHEREAS, Exelis and Snohomish County agree that it is interest of both parties to proceed with the proposed option for the Public Access Portal at this time;

IN CONSIDERATION OF the mutual promises and coverants and agreement contained herein, the Parties agree as follows:

1. Within 10 business days of the Execution Date of this change order, Harris' commercial off-the-shelf version of Symphony® PublicVueTM (PublicVue) will be deployed for Snohomish County. PublicVue is a web enabled centrally hosted solution that delivers an advanced modern Public Flight Tracking System. The PublicVue solution with its high quality flight tracking capabilities provides robust visualizations and extensive analytical tools to the public.

Key PublicVue features include:

- High definition, configurable displays that run on a number of standard Web browsers (IE, Safari, Firefox, Chrome) and are accessible on tablets and smart phones (iOS, Windows, and Android)
- Real-time (with 10 minute security delay) and historical replay flight tracking options are available
- Complaint creation is fully integrated and auto-populates flight information into the complaint
- Public has the ability to use smartphone or tablet location to center the map display and show relative aircraft position, bearing and altitude
- Address Lookup and Locate Me tools enable public to define location and show the relative position of the aircraft to that location
- Existing integration with EnvironmentalVue NOMS system enables the public to submit complaints via PublicVue that will directly populate into the NOMS complaint database
- Data accuracy, transparency and consistency in what the public sees through PublicVue and what the Noise office analyzes and reports through EnvironmentalVue
- Intuitive, user customizable displays, including 7 different map overlays and real-time weather overlays



- Tabular data supports map filtering (arrivals, departures and over-flights) for public users who are interested in analyzing particular operations
- User configurable flight data tags, pop-up labels, icon sizing and colorization
- Flight following with optional display of the full flight path and slant angle feature shows homeowners the exact route and profile of a flight in the vicinity of their location
- 2. Exelis will provide one (1) hour of WebEx training on Symphony PublicVue to Snohomish County.
- 3. This Change Order increases the five year contract price as outlined below. The initial implementation fee has been waived and pricing for PublicVue has been reduced from the original pricing quoted for contract years 3 through 5 to the annual pricing as follows:
 - Year 3 \$15,000 (Annual rate will be prorated based on change order Execution Date)
 - Year 4 \$15,450
 - Year 5 \$15,914
- 4. This Change Order is dependent upon Snohomish County maintaining its existing products and services under Contract No. 075-13.
- 5. Effective May 29th, 2015, the transaction whereby Harris Corporation acquired Exelis Inc. was completed. As a result, Exelis Inc. is a wholly-owned subsidiary of Harris Corporation. At this time, the business unit structures and associated legal entities of Harris and Exelis will remain intact for bidding and performance purposes. Upon the dissolution of Exelis, Snohomish County agrees to assign this Contract in full to Harris Corporation.

All other terms and conditions of the Contract remain unchanged.
