Consideration:

The proposed motion would approve and authorize the County Executive to execute Amendment 7 to the Website Development and Hosting Agreement with Icon Enterprises Inc. D/B/A CivicPlus, pursuant to SCC 3.04.140(8).

Background:

Snohomish County entered into an agreement for Website Development and Hosting in 2013 with Icon Enterprises Inc, DBA CivicPlus. Emergency Orders¹ for Snohomish County encourages the use of technology to provide easy public access for residents. The County continues to implement additional functionality and online services in response to the Covid-19 pandemic.

The proposed motion would add a digital accessibility compliance tool that would allow all users of varying ability to fully access the County's website content and would allow for an enhanced integrated website development suite, enabling the County to create more complex and modern context.

Current Proposal:

Scope: The proposed Amendment 7 would add AudioEye Managed and Design Center Pro to the Agreement.

Duration: Amendment 7 of the agreement is from execution from through July 31, 2023.

Fiscal Implications: The first term ending 7/31/2022 will be pro-rated based on execution date; fee from 8/1/2022 – 7/31/2023 is calculated to be \$42,083.00.
