SCC 2.460.030 establishes the creation of the Snohomish County Human Rights Commission. It is made up of nine members nominated by the Executive and approved by the County Council. Of these nine, one shall represent the County Executive, one shall represent the law enforcement community after consultation with the County Sheriff, five shall represent the five County Council Districts following consultation with each County Council member, and the other two to serve as Member at Large. The commission shall serve in an advisory capacity to the County Executive, County Council and other county officers in matters concerning human rights. Terms of service are 3 years. Meetings are currently the first Thursday of each month from 6:00-8 p.m.
