1. Summary

The ARCHIBUS software is a 3-year period consisting of 1 Year with 2 optional years. The software is owned and licensed by Eptura, Inc. and has three major components, Web Central Core, Number of Concurrent users and activities.

Additional software activities agreed to in writing by both parties will be prorated to the end of the term.

The End of Sale for Perpetual Licensing in Archibus. Customers who currently use perpetual licenses have an On-premises subscription-based license. Timeline for the transition:

- October 31, 2024: No additional perpetual licenses will be sold after this date
- October 31, 2025: No renewals will be accepted after this date
- October 31, 2026: All support for perpetual licenses will officially cease after this date
- July 31st, 2025, Early term conversion discount expires or when your current Software License Expiration of 7/10/2025 whichever comes first.

The term of the ARCHIBUS Software is a 1 year and 6-month non-cancellable term with two 1 Year Options and can be terminated with a 60-day written notice prior to the renewal date. The software term is from 7/11/2025 to 7/10/2028. At the end of the term a new software term SOW is submitted by ADSI for approval by the Snohomish County. If not approved before the end of the term, Snohomish County access to the ARCHIBUS software will terminate.

New versions of the ARCHIBUS software are being released on a semiannual basis. While performing upgrades at every point release may not be necessary depending on the feature, function, and new activities it is recommended to stay on the most current full release of the application.

Term licenses supply participants with both revision and version-level ARCHIBUS upgrades released during their paid term period; however, access to programs/features licensed separately is not included.

SNOHOMISH COUNTY use of ARCHIBUS will be subject to the ARCHIBUS Term Based End User License Agreement, currently at: https://archibus.com/wp-content/uploads/2023/06/Eptura_Archibus-EULA_Term_v1.0_May-2023.pdf or otherwise located at <https://eptura.com/terms/>. Upon the execution of this SOW, SNOHOMISH COUNTY expressly accepts and agrees to be bound by the ARCHIBUS Term Based End User License Agreement. SNOHOMISH COUNTY shall execute, accept and be bound by any updated agreements as reasonably requested by Eptura.
