#### 6. Committee of the Whole

a. Ordinance 23-083, approving and authorizing the County Executive to execute an interlocal agreement by and between Snohomish Regional Fire & Rescue and Snohomish County for Evergreen State Fair Park fire protection and related services

2023-0954

Deb Bell, Sr. Legislative Analyst, stated that this ordinance would approve and authorize the County Executive to execute an interlocal agreement (ILA) with Snohomish County Fire Protection District 7 for fire protection and emergency response services at the Evergreen State Fairgrounds. She provided details of the ILA and said under the agreement, services would be provided at the fairgrounds in the not to exceed amount of \$83,664.84, backdating the start date to January 1, 2023, through December 31, 2023.

Councilmember Low noted Ms. Bell referenced Fire District 7 in her staff report and asked if the contract has been updated with their new name. Tom Teigen, Conservation and Natural Resources Director, responded and said he would double check to make sure the name is correct in the contract and ordinance.

**ACTION**: Vice-Chair Nehring made a motion to set time and date for a public hearing for Wednesday, September 13, 2023, at the hour of 10:30 a.m. Councilmember Low seconded the motion and it carried unanimously.

b. Motion 23-344, approving entertainment contract for the International Lumberjack Show LLC at the 2023 Snohomish County Evergreen State Fair

Deb Bell, Sr. Legislative Analyst, provided a staff report and stated the total cost of the contract is \$34,000.00.

**ACTION:** Vice-Chair Nehring made a motion to approve Motion 23-344. Councilmember Dunn seconded the motion and it carried unanimously.

c. Motion 23-343, authorizing the Snohomish County Executive 2023-0953 to execute FAA Airport Improvement Grant Offer No. 3-53-0028-066-2023 at Snohomish County Airport at Paine Field for East GA Apron & Taxiway Foxtrot Rehabilitation Project

Ryan Countryman, Sr. Legislative Analyst, provided a staff report and spoke briefly of the pavement rehabilitation improvements the grant would cover at Paine Field. He said the County would receive \$5,500,000.00, which is 90% of the anticipated total cost. The County would provide a 10% local fund contribution of \$611,112.00 from Airport Enterprise Fund 410, the work is expected to be complete in Summer 2024, and there is no impact to the General Fund 002.

**ACTION:** Vice-Chair Nehring made a motion to approve Motion 23-343. Councilmember Low seconded the motion and it carried unanimously.

**d.** Amended Motion 23-345, appointing Jay Downing to the Snohomish County Parks Advisory Board

Ryan Countryman, Sr. Legislative Analyst, provided a staff report and explained this motion would appoint Jay Downing to the Parks Advisory Board to complete a vacant partial first term representing District 1 and ending in January 2027. Mr. Countryman explained an oral amendment is necessary to correct the termination date in the motion. He explained the motion currently has a termination date of January 1st and the Code requires a January 15th termination date. Mr. Countryman continued and provided background information for Mr. Downing.

**ACTION:** Vice-Chair Nehring made motion to approve Motion 23-345. Councilmember Low seconded the motion.

Vice-Chair Nehring made a motion to change the termination date to January 15, 2027. Councilmember Low seconded the motion and it carried unanimously.

The question was called for and the motion to approve Motion 23-345, as amended, carried unanimously.
