AGREEMENT FOR PROFESSIONAL SERVICES – AMENDMENT NO.2
AGREEMENT NO. CC08-20

THIS AMENDMENT NO.2 to that certain Agreement for Professional Services (the “Agreement”) executed on December 21, 2020, is made by and between Snohomish County, a political subdivision of the State of Washington (the “County”) and Tetra Tech, Inc., a Delaware corporation (the “Consultant”).

NOW, THEREFORE, for and in consideration of the benefits conferred on both parties and the mutual promises set forth below, the parties agree that the Agreement be amended as follows:

1. Term of Agreement; Time of Performance. This Agreement shall be effective upon Execution (the “Effective Date”) and shall terminate on June 30, 2024, PROVIDED, HOWEVER, that the term of this Agreement may be extended or renewed for up to one (1) additional one (1) year term, at the sole discretion of the County, by written notice from the County to the Consultant. The Consultant shall commence work upon the Effective Date and shall complete the work required by this Agreement no later than June 30, 2024, PROVIDED, HOWEVER, that the County’s obligations after December 31, 2023, are contingent upon local legislative appropriation of necessary funds for this specific purpose in accordance with the County Charter and applicable law.
2. Contract Maximum. Total charges under this Agreement, all fees and expenses included, shall not exceed \$145,000.000 (excluding subsequent extensions or renewals, if any).
