

**AMENDMENT NO. 2 TO THE SOFTWARE LICENSE AND SERVICES AGREEMENT  
RELATING TO AUTOMATED CASHIERING SYSTEM**

This Amendment No. 2 to the Master “Software License and Services Agreement Relating to Automated Cashiering System,” dated January 19, 2010, is made and entered into this 1 day of DECEMBER, 2020, by and between Snohomish County, a political subdivision of the State of Washington (hereafter “the County”) and N. Harris Computer Corporation d/b/a Systems Innovators, a division of N. Harris Computer Corporation, a Canadian corporation whose address is 1 Antares Drive, Suite 400, Ottawa, Ontario, Canada K2E8C4, (hereafter “the Contractor”).

**RECITALS**

Whereas, the Contractor has developed and owns certain proprietary software for use in Automated Cashiering and Payment Collections; and

Whereas, the Contractor and County entered into that certain Agreement relating to automated cashiering system on January 19, 2010; and

Whereas, the Agreement term was extended for one year by mutual written agreement through Amendment 1, entered into on January 7, 2020; and

Whereas, the Agreement term will end on January 18, 2021, unless extended by mutual written agreement, and the County wishes to continue to use the System and receive Maintenance and Support Services as described in Schedule “D” Support and Maintenance Agreement, and Contractor wishes to continue to provide the Services;

**AGREEMENT**


NOW, THEREFORE, in consideration of the covenants hereinafter set forth and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the County and Contractor agree as follows:

1. Section 5. Term of Agreement, shall be amended to add a new subsection 5.1.6 that shall read as follows:
  - 5.1.6 Term of Agreement shall be extended for an additional three-year term through January 18, 2024.
  
2. Section 7. Price and Payment shall be amended to add a new Subsection 7.7 that shall read as follows:
  - 7.7 Maintenance and Support fees for the period of:
    - a) January 19, 2021 through January 18, 2022 shall be \$7,051.06 plus applicable sales tax, and
    - b) January 19, 2022 through January 18, 2023 shall be \$7,051.06 plus applicable sales tax, and

c) January 19, 2023 through January 18, 2024 shall be the \$7,192.08 plus applicable sales tax.

3. Except as expressly provided in this Amendment No. 2, all terms and conditions of the Master Agreement, as amended, remain in full force and effect.
