On January 31, 2020, the United States Department of Health and Human Services 17 secretary Alex Azar declared a public health emergency for COVID-19, beginning January 27, 18 19 2020. On February 29, 2020, Washington State Governor Jay Inslee proclaimed a public health 20 emergency for COVID-19. On March 4, 2020, the Snohomish County Health Officer proclaimed a countywide public health emergency for COVID-19. On March 4, 2020, 21 22 Executive Dave Somers issued a "Local Proclamation of Emergency Snohomish County" for COVID-19 (the "Emergency"). On March 13, 2020, the President of the United States of 23 24 America declared COVID-19 a National Emergency; 25 26 WHEREAS, on March 10, 2021, the United States Congress passed the American Rescue 27 Plan Act of 2021 ("ARPA"); 28 WHEREAS, Section 9901 of ARPA created a Coronavirus State Fiscal Recovery Fund 29 and a Coronavirus Local Fiscal Recovery Fund; and 30 31 WHEREAS, the United States Department of Treasury provided direct relief to units of 32 33 local government through the Coronavirus Local Fiscal Recovery Funds ("CLFR"); and 34 WHEREAS, Spohomish County has received CLFR funds from the United States 35 36 Department of Treasury; 37 38 NOW, THEREFORE, BE IT ORDAINED: 39 40 Section 1. The County Council makes the following findings of fact: a supplemental 41 appropriation in the amount of \$56,610,388 is necessary in the Grant Control Fund 130 for 42 budget year 2021 to provide expenditure authority for direct aid provided to Snohomish County 43 from the United States Department of Treasury pursuant to Section 9901 of ARPA. 44
