1. Executive Summary

1. Executive Summary

The ARCHIBUS software is a 1-year perpetual Software Subscription and consists of thirty-seven activities which can be individually licensed. 's configuration consists of fourteen of these activities including Room Inventory, personnel & Occupancy and Space Chargeback, corrective, and Preventive Maintenance. Then to track lease information the Portfolio, Lease, and cost administration activities.

The ARHCIBUS software is owned and licensed by Eptura, Inc. and has three major components, Web Central Core, Number of concurrent users and activities.

Applied Data Systems is a reseller of ARCHIBUS software and has been hosting clients Facilities Management applications since 1996. With over 23 years of expertise in hosting these applications in our datacenter and providing the support needed to keep these applications running at peak performance. Our hosting clients range from one user up to enterprise deployments of over one hundred users, with offices locally, nationally, and globally. Along with our knowledge of the applications and hosting infrastructure, Applied Data Systems can also provide technical support, consulting, and services in maintaining the application and data.

The PAAS (Platform as a Service) is where the client maintains the cost for the ARCHIBUS term software license including any changes to the configuration or customizations. ADSI provides the infrastructure to run the software, which includes MSSQL Server Database, Apache/Tomcat instance, Email Relay, Secured FTP, SSL encryption for the URL and Backups of the data. In Addition, ADSI maintains the patching of the servers needed to support the hosted environment.

For more than 30 years Applied Data Systems, professional services have provided support for the activities which is identified in the software configuration.

2. Project Summary; Term

This project consists of software, ADSI Cloud Hosting and Professional Services hours.

C. ADSI Cloud Hosting

Security for authenticating to the URL is via Standard Web Central Login or SAML authentication. Drawings and Asset AutoCAD drawings can be uploaded and checked in/out as needed.

Data is replicated to our DR site through our SAN snapshots, which is separate from our electronic and tape backup. In the event of a catastrophic outage in our Primary Data Center ADSI will begin the restoration of client services in our DR site. Our primary Data center has several redundancies built into it, such as power, cooling, and infrastructure.

As part maintaining a secure environment ADSI performs a 2-hour monthly outage window to apply patches on the Servers, Switches, Firewalls, etc.... a notification is sent 24 hours prior to the maintenance window, apart from a Zero day patch a notification may be sent prior applying the patches outside of the maintenance window. In addition, if a client has customizations which are specific to their installation, a deployment and restart may be needed outside of the monthly patching cycle.

Clients can opt out of the monthly tape backups. A daily electronic backup is maintained for 2 weeks, If the requirement is at the end of the term of the hosting agreement that all backup tapes which are encrypted and maintained for 5 years, requires that client data be removed, then an hourly rate of \$175.00 per hour is applied to remove data from the tapes.

7. Assumptions:
