**Subject:** Amendment No. 2 with ODAT Services LLC for Substance Use Peer Navigation Support

**Scope:** Amendment No. 2 to the contract with ODAT Services LLC for peer navigation replaces Schedule A – Contract Scope and Schedule B - Compensation.

**Revised Schedule A – Contract Scope:**

- Increases the number of full-time peer navigators from one to two full time navigators.
- The second FTE is funded by the CDC Foundation and the salary for this position is not included in the contract.
- Contract includes oversight of both navigators.
- Provides for the purchase and distribution of incentives and wellness kits (value may not exceed \$30) that may include medical supplies and toiletries. Wellness kits are funded by the CDC’s Overdose to Action funds.

**Revised Schedule B – Compensation:**

- Increases monthly expenditure for services by the Program Manager and adds provision of services by the Program Founder.
- Increases monthly expenditure from \$8,761.50 to \$13,437.87.

Amendment No. 2 increases the contract maximum to \$140,250 (from \$105, 200) and extends the contract period until August 31, 2026.

**Duration:** May 1 , 2025, through August 31, 2026, and may be extended for up to two additional one-year terms.

**Authority Granted:** Motion 26-138 authorizes the Executive to sign Amendment No.2 with ODAT Services LLC for peer navigation support for unhoused individuals who use drugs in Snohomish County.

**Background:** On July 11, 2025, Snohomish County executed a contract with ODAT Services LLC for peer navigation in the amount of \$35,050. The scope of the contract includes:

- One full-time Peer Navigator will provide non-stigmatizing, non-judgmental support to people who use drugs (PWUD) in Snohomish County, especially those at risk of becoming unhoused.
- Documentation of engagement.
- Build and maintain relationships with health and social services.
- Adapt program activities based on ongoing evaluation results as determined by the Department of Health.
- The contractor will:
  - Ensure Peer Navigator maintains Peer Counselor or Recovery Coach certification.
  - Meet each client to identify client's readiness for services.
  - Conduct individual, crisis, and family support.

On October 1, 2025, Council passed Motion 25-420<sup>1</sup>, approving Amendment No.1 to the contract with ODAT for peer navigation. The amendment extended the contract through April 30, 2026. The contract total was increased by \$70,150, bringing the total not to exceed amount to \$105,200.

**Requested Action:** Move to the GLS agenda for Council consideration.
