- The CONTRACTOR will commence the work required by the Contract Documents within <u>twenty-one</u>, (21) calendar days from the date of Contract Execution or as otherwise specified in the contract documents, and will achieve Physical Completion of the work within _____ working days, unless the period for Physical Completion is extended otherwise in accordance with the Contract Documents.

- 6. The OWNER will pay the CONTRACTOR in the manner, at such times, and in such amounts as set forth by the Contract Documents.
- 7. The CONTRACTOR must verify mandatory responsibility criteria for each first tier subcontractor, and its subcontractors of any tier that hire other subcontractors must verify mandatory responsibility criteria for each of its subcontractors. Verification shall include that each subcontractor, at the time of subcontract execution, meets the responsibility criteria listed in RCW 39.04.350(1) and SCC 3.04.131(2) and Subcontractors who will perform the work of structural steel installation, rebar installation, heating, ventilation, air conditioning and plumbing as described in RCW 18.106 and electrical as described in RCW 19.28, or an elevator contractor license, if required by Chapter 70.87 RCW.
- 8. Form FHWA 1273, Revised May 1, 2012 is attached hereto and made part of this Contract as Exhibit A.
- 9. This Contract shall be binding upon all parties hereto and their respective heirs, executors, administrators, successors, and assigns.
