## ORDINANCE NO. 23-088

#### GRANTING A NON-EXCLUSIVE FRANCHISE AUTHORIZING LIMITED USE OF THE PUBLIC ROAD RIGHTS-OF-WAY IN PORTIONS OF UNINCORPORATED SNOHOMISH COUNTY, WASHINGTON TO THE CITY OF MARYSVILLE

The City of Marysville, a municipal corporation, has applied to Snohomish County, Washington, for a non-exclusive franchise to construct, maintain, operate, replace and repair water and sanitary sewer systems in, on, across, over, along, under, and/or through public rights-of-way within the following portions of unincorporated Snohomish County:
