<u>Authority Granted:</u> Approves and authorizes the County Executive to sign Amendment No. 3 to Professional Services Agreement CC03-23 with Cascade Northwest Services, LLC, dba. ARCpoint Labs for the amount of \$250,000, for a total amount not to exceed \$412,052, under SCC 3.04.140(11).

<u>Background:</u> In 2022 the Department of Public Works issued RFP-22-040LY to select a firm to conduct pre-employment physical abilities testing and Hepatitis B vaccinations, as Public Works has several programs where employees have an increased risk of exposure to Hepatitis B. ARCpoint Labs was selected through all established Federal, State and County policies and practices. Two amendments have been administratively approved.
