AUTHORIZING THE EXECUTIVE TO SIGN AN AMENDMENT WITH WESTERN WASHINGTON MEDICAL GROUP, INC, P.S., DBA LAKE SERENE CLINIC TO PROVIDE SEXUALLY TRANSMITTED DISEASE SERVICES IN SNOHOMISH COUNTY

WHEREAS, Snohomish County, acting through its Health Department, previously entered into an Agreement with Western Washington Medical Group, Inc, P.S., dba Lake Serene Clinic to provide sexually transmitted disease (STD) services in Snohomish County to Snohomish County residents specifically identified who have been provided a referral voucher from the Health Department; and

WHEREAS, the parties wish to amend and reinstate the agreement to increase the maximum not to exceed amount of the agreement; and

WHEREAS, the Snohomish County Health Department recognizes the public health, safety, and welfare benefits of promoting wider availability of STD treatment and services within Snohomish County, and

WHEREAS, these services are core public health services that the Snohomish County Health Department performs; and

WHEREAS, Western Washington Medical Group has a desire to assist vulnerable communities in need of STD treatment and services; and

WHEREAS, Western Washington Medical Group is a trusted voice in the community and has proven itself as a valuable partner to the Health Department and has been instrumental in STD treatment and services within Snohomish County; and

WHEREAS, Western Washington Medical Group and the Snohomish County Health Department have a current need to enter into an amendment to increase the not to exceed amount of the agreement by an additional \$15,000 for payment for services through the end of December 31, 2023;

NOW, THEREFORE, ON MOTION, the County Council hereby authorizes the Executive to sign an amendment with Western Washington Medical Group, Inc, P.S., dba Lake Serene Clinic in substantially the form as that attached hereto as Exhibit A.

**REINSTATEMENT AND AMENDMENT NO. 1
TO AGREEMENT
BETWEEN SNOHOMISH HEALTH DISTRICT AND WESTERN WASHINGTON
MEDICAL GROUP, INC, P.S., DBA LAKE SERENE CLINIC**

This Amendment No. 1 is made and entered into on the 28th day of February, 2024, between SNOHOMISH COUNTY, hereinafter called "County" and WESTERN WASHINGTON MEDICAL GROUP, INC, P.S., DBA LAKE SERENE CLINIC hereinafter called the "Contractor."

WHEREAS, the parties hereto have previously entered into an Agreement for Contractor to provide sexually transmitted disease (STD) services in Snohomish County to Snohomish County residents specifically identified who have been provided a referral voucher from the Health Department.

NOW THEREFORE, the Agreement is hereby amended as follows:

1. **Reinstatement of the Agreement.** The Agreement between the County and the Contractor expired on December 31, 2023. This Amendment reinstates all of the terms of the original Agreement and increases the compensation by \$15,000, for a total not to exceed amount of \$40,000.
2. **Amend Section 3.f. Compensation, Contract Maximum.** Total charges under this Agreement, all fees and expenses included, shall not exceed FORTY THOUSAND DOLLARS (\$40,000) for the initial term of this Agreement.

IN WITNESS THEREOF, Western Washington Medical Group, Inc, P.S., has caused this Amendment to the Agreement dated September 20, 2023, to be executed by its Director of Primary Care, and Snohomish County has caused this Amendment to be executed by its County Executive, each of whom have authority to bind their respective entities.


