Subject: Master Services Agreement with Gateway International 360, LLC.

Scope:

Provide Electric Vehicle Supply Equipment (EVSE) and Charge Management Software (CMS), including collaboration with the County's subcontractors (such as electrical engineers, construction and relevant trades) for the installation of Level 2 and Level 3 EVSE infrastructure.

GWI360 will provide Level 2 charging equipment, CMS software, communication, commissioning and integration, training for Fleet personnel, and post-installation service and support to Snohomish County Fleet Services for two initial projects:

- Main Campus: 20 Dual port wall box Atom Power E50 Series (AEV-48WB-D)
- Cathcart Way Operations Center: 10 Dual port pedestal -Atom Power E50 Series (AEV-48CMPED-D)

The proposed projects were in the adopted 2024 budget and continued into the adopted 2025-2026 biennial budget. Due to funding requirements these initial projects are to be completed in 2025. Background: Gateway International 360 LLC was the highest scoring firm that responded to RFP-24-0328RB-S and was selected through established Federal, State and County policies and practices to provide phased, comprehensive Electric Vehicle Charging Solutions that include fleet, public-facing and workplace charging infrastructure.
