Consideration

The Executive’s Office requests Council consider Motion 22-270 through 22-273, confirming three reappointments and one new appointment to the Evergreen State Fair Advisory Board for Kathleen Wright, Elaine Johannsen, Judi Smith, and Ivan “Drew” Andrew.

Background

Snohomish County Code [2.32.070](#) established the Fair Advisory Board to assist the Fair Manager and the county in the operation and production of the Evergreen State Fair. The Board is comprised of 11 members, one from each of the five Council Districts, and six at-large members. Membership is dictated per SCC [2.03](#); members serve for terms of four (4) years and may serve a maximum of three consecutive terms.

Members who reach their maximum number of terms may, after a period of two years, again be nominated for appointment to the board.¹
