

Dear Councilperson Dunn,

I recall very well the last major appointment. It was to county council. The people making the selection and the basic process was the same. PCOs relay their will to council, and council made the appointment.

The person the council selected was Jared Mead. The reasoning at the time was that he was clearly preferred by the PCOs. He did receive double the votes of the other contenders (including a qualified woman of color) and that we (and the council) should listen to the will of the people and vote of PCOs.

The reason I recall this so vividly is because I (and others) were recruited at the time to whip those votes, and were told they were crucial to getting appointed. Interestingly, the vote of the PCOs in this case was even more lopsided than that vote.

And so it seems very strange now that there is a lot of "behind the scenes" work being done (in some cases by the same people) trying to make the case to NOT listen to the PCOs this time. Those efforts include pressure for a complete letter writing campaign, not just from PCOs and voters. Imagine my surprise when I even received word from the head of a prominant political organization, where they told me they received a call from a beneficiary of the previous logic, soliciting them to write a letter to the council on behalf of a candidate, clearly not preferred by the PCOs.

In addition to being incongruent with the previous logic, this in my view is also very disrespectful to the PCOs of the 44th legislative district. It would be different if their desire were remotely close. Then there would be room for interpretation and a decision to be made. In this case however, the PCOs spoke loud and clear with nearly a 3 to 1 vote for their preference.

The ethical answer here is to avoid the back room shenanigans and honor the will of the people. Honor democracy and the PCOs that just gave a very clear message to the council.

It has come to my attention that you have not yet pledged to support the 1st vote getter Sean Paddock for the appointment to replace former Representative John Lovick. I would like to remind you that Sean Paddock was selected by the Precinct Committee Officers of the 44th Legislative District by a vote of 31 – PCO 12.

If true, this information is extremely troubling. Daily, the news reports how Republican Legislators are actively pushing legislation to overturn the will of the voters should they vote for candidates they oppose. Overturning the will of the 44th LD PCOs is tantamount to the Republican strategy and is certainly undemocratic.

Additionally, this action reminds me of a prior appointment that has proven disastrous for democratic party in Snohomish. I'd like to remind you of the appointment of Hans Dunshee to the County Council District 5 seat. You may remember that he was not the top vote getter and there were concerns that he would be a weak candidate. However, the County Council appointed him, citing their friendship as a large reason for the appointment when I reached out to them about the choice, and it proved to be disastrous. The overturning of the PCO vote resulted in PCOs who refused to support Hans in his race to keep the position he was appointed in. This led to a weaker ground game paired with a candidate who did not actively run the type of aggressive campaign that was necessary to win. Sam Low defeated Hans, and we have yet to get that County Council Seat back into the hands of Democrats.

I am worried that we will see this again in the 44th. Neither Brandy nor Joyce had strong support in the PCO appointment process, and I have seen the type of anemic ground game race that Brandy has run in the past numerous times. In her own race against Sam Low, I witnessed zero contact or support from the Maltby region which she will need to do to win the new 44th boundaries. We could see a repeat in history, with a weak candidate in the 44th opening up for the return of a purple 44th District. I urge you to not make the mistakes of the prior council leadership and consider the dangers associated with the 2nd place candidate for the appointment.

More than ever, we need unity in the democratic party, not a divisive choice for a divisive candidate. I am not yet a member of the 44th, but I will be districted. I urge you to not overturn the PCO vote and appointed Sean Paddock so that I may come into a 44th that is unified instead of fractured and distrustful of local politics.

The vote of the PCOs should be respected, as you have yourself stated in the past. I also would like to say that I know from prior conversations with the candidate Brandy Donaghy, she repeatedly urged me to respect the PCO appointments as well. I am writing today to ask you to please respect the will of the 44th LD Democratic PCOs and appoint Sean Paddock to (soon to be vacant) 44th LD House Representative Position 1. On Dec 5th, Sean was the top vote recipient for this position, receiving the clear majority of 31 votes (62%). Brandy Donaghy came in at a far second, receiving only 12 votes (24%). Anne Anderson received 6 votes (12%) and Joyce Copley received 1 vote (2%).

I am sending you this email in response to Councilman Mead's Facebook post on Dec 10th, asking individuals to send emails and phone calls with their opinions to the council members, indicating he was "keeping an open mind" for the appointment. In direct contrast with this unbiased claim, I was also informed that he personally reached out to at least one external organization, asking them to send a letter of support for Brandy to the councilmembers, after she had only received 12% of the vote. During Councilmember Mead's appointment to the council in 2020, he worked diligently to garner the largest number of PCO votes, explaining to me at the time, that a clear majority of PCO votes would secure his appointment. All this contradiction and encouragement to inject personal biases flies in the face of the PCOs and shows a high level of disrespect toward elected officials who are granted this power by the party. On a related note, I was saddened during the vote on Dec 5th while conversing with a fellow PCO who said they were "sitting the vote out because the PCO votes wouldn't matter, and the council would appoint whoever they wanted". I am saddened and shocked to realize one at least one councilmember indicating as such.

Aside from the glaring majority of votes received by Sean, I have my own reasons as to why I supported him with my vote on Dec 5th. As a Democrat, I believe

everyone should have the opportunity to succeed. I believe in giving POC, women, and LGBTQ+ folks extra assistance that white, cis-gender male counterparts do not need. As a data-driven person, I blend my personal morals and beliefs with data to reach the most logical conclusions for my whole self and to the betterment of my community. I have extensive experience working on campaigns, and it is with this lens in which I rely on when deciding where to spend my energy during campaign season. Dear Council Person Wright

I recall very well the last major appointment. It was to county council. The people making the selection and the basic process was the same. PCOs relay their will to council. And council made the appointment.

The person the council selected was Jared Mead. The reasoning at the time was that he was clearly preferred by the PCOs. He got double the votes of the other contenders (including a qualified woman of color) and that we (and the council) should listen to the vote of PCO's.

The reason I recall this so crisply is because I and others were recruited at the time to whip those votes, and were told they were crucial to getting appointed. Interestingly, the vote of the PCOs in this case was even more lopsided than that vote.

And so it seems very strange now that there is a lot of "behind the scenes" work being done (in some cases by the same people) trying to make the case to NOT listen to the PCOs this time.

Those efforts include pressure for a complete letter writing campaign, not just from PCOs and voters. Imagine my surprise when I even received word from the head of a prominant political organization, where they told me they received a call from a beneficiary of the previous logic, soliciting them to write a letter to the council on behalf of a candidate, clearly not preferred by the PCOs.

In addition to being incongruent with the previous logic, this in my view is also very disrespectful to the PCOs of the 44th legislative district. It would be different

if their desire were remotely close. Then there would be room for interpretation and a decision to be made. In this case however, the PCOs spoke loud and clear with nearly a 3 to 1 vote for their preference.

The ethical answer here is to avoid the back room shenanigans and honor the will of the people. Honor democracy and the PCOs that just gave a very clear message to the council.
