MOTION AUTHORIZING THE EXECUTIVE TO SIGN AMENDMENT NO. 1 FOR NALOXONE  
DISTRIBUTION BETWEEN SNOHOMISH COUNTY  
AND CITY OF ARLINGTON

WHEREAS, the Snohomish Health District was integrated into Snohomish County effective December 31, 2022, and now operates as the Snohomish County Health Department; and

WHEREAS, prior to its integration into Snohomish County, the Snohomish Health District entered into an agreement with the City of Arlington, for the distribution and acceptance of naloxone; and

WHEREAS, the Snohomish Health District assigned its interest in the Original Agreement to Snohomish County effective December 31, 2022; and

WHEREAS, the Snohomish County Health Department recognizes the public health, safety, and welfare benefits of promoting wider availability of naloxone within Snohomish County, and

WHEREAS, the Snohomish County Health Department wishes to continue our partnership with the City of Arlington and continue the distribution and acceptance of naloxone with first responders; and

WHEREAS, the City of Arlington has a desire to assist vulnerable communities in need of naloxone; and

WHEREAS, in exchange for naloxone, Snohomish County Health Department will receive data regarding opioid overdoses occurring within Snohomish County; and

WHEREAS, Snohomish County, acting through the Health Department, have executed numerous naloxone distribution agreements, and this agreement does not represent a new program;

NOW, THEREFORE, ON MOTION, the County Council hereby authorizes the Executive to sign an amendment with City of Arlington for the distribution and acceptance of naloxone in substantially the form as that attached hereto as Exhibit A.

EXHIBIT A

**AMENDMENT NO. 1 TO NALOXONE DISTRIBUTION AGREEMENT  
BETWEEN SNOHOMISH COUNTY AND  
CITY OF ARLINGTON**

This Amendment No. 1 is made and entered into on the 1st day of September, 2025, between SNOHOMISH COUNTY, hereinafter called "County," and CITY OF ARLINGTON, hereinafter called the "Contractor."

WHEREAS, the Snohomish Health District was integrated into Snohomish County effective December 31, 2022, and now operates as the Snohomish County Health Department; and

WHEREAS, prior to its integration into Snohomish County, the Snohomish Health District entered into an agreement with Contractor on September 23, 2022, for the distribution and acceptance of naloxone (the "Original Agreement"); and

WHEREAS, the Snohomish Health District assigned its interest in the Original Agreement to Snohomish County effective December 31, 2022; and

WHEREAS, both parties desire to extend the term of the Original Agreement;

NOW THEREFORE, in consideration of the terms, conditions, covenants and performance contained herein or attached and incorporated, and made a part hereof, the parties hereto agree as follows:

1. Section 4 of the Original Agreement is hereby amended in its entirety to read as follows:

This Agreement shall be effective upon full execution of this Agreement by the parties (the "Effective Date") and shall terminate on December 31, 2030, PROVIDED, HOWEVER, that the term of this Agreement may be extended or renewed for up to two (2) additional five (5) year terms, at the sole discretion of the County, by written notice from the County to the Contractor. The Contractor shall commence work upon the Effective Date and shall complete the work required by this Agreement no later than December 31, 2030, PROVIDED, HOWEVER, that each Party's obligations after December 31, 2025, are contingent upon local legislative appropriation of necessary funds for this specific purpose in accordance with applicable law.

2. All other terms and conditions of the Original Agreement shall remain in full force and effect except as expressly modified by this Amendment No. 1.


IN WITNESS THEREOF, Contractor has caused this Amendment No. 1 to the Original Agreement, to be executed by its City Administrator, and the County has caused this Amendment No. 1 to be executed by its Executive, each of whom have authority to bind their respective entities.
