



APPROVING AND AUTHORIZING THE COUNTY EXECUTIVE TO SIGN THE INTERLOCAL AGREEMENT BETWEEN THE STATE OF WASHINGTON DEPARTMENT OF FISH AND WILDLIFE AND SNOHOMISH COUNTY FOR OPERATION AND MAINTENANCE OF PUBLIC ACCESS OF CHINOOK MARSH

Summary: The ordinance approves an Interlocal Agreement with State Washington Department of Fish and Wildlife (WDFW) for the operation and maintenance of public access of Chinook Marsh. The County has previously acquired real property for the project area commonly known as Chinook Marsh located within the Snohomish River Estuary. The Chinook Marsh Restoration project site lays within an area designated as a "no shooting area" except for shotgun shooting during legal open hunting season under chapter 10.12 Snohomish County Code (SCC) and has been informally used for waterfowl hunting for multiple decades. Pursuant to 39.34 RCW, the parties wish to allow WDFW to access, maintain and operate hunting amenities on the Property for the benefit of the public, while the County continues to maintain ownership.

At the Public Hearing, the Council may consider amendments to the proposed ordinance.




