**Navigation Program** 

**Scope:** Amendment #3 would extend the duration of the contract by a full year,

now expiring August 31, 2026 and add an additional \$206,500 to the contract, bringing the new do not exceed amount to \$475,000. New expenses under this amendment are \$333 dollars for training and \$50 for

gift cards for speakers.

<u>Background:</u> On July 17, 2024 Council approved an agreement with Ideal Option for a Substance Use Peer Navigation Program. Under this program, the contractor will "provide care and support to individuals in Snohomish County using substances who might also be incarcerated, homeless, or have recently experienced an overdose" through two full time Peer Navigator positions. Schedule A of the contract outlines outcomes and expectations of these two positions and Schedule B outlines the compensation (salary/benefits, supplies, cell phone, transportation, and an indirect rate). The contract has been amended twice to extend the contract duration and add additional funding. Amounts and durations are listed in the table below.
