Background: The project, in conjunction with the City of Bothell, is to improve 228th St SE. This includes widening the designated portion from the existing 3-lanes to 4-lanes and adding bike lanes, intersection improvements, curbs, gutters, sidewalks, lighting, signals, and integrated signal configurations.
