NOTICE OF ENACTMENT

NOTICE IS HEREBY GIVEN, that on June 10, 2026, the Snohomish County Council approved Ordinance 26-015.

**Background:** Vijay and Anju Auluck ( the “Petitioners”) submitted Vacation Request # 25-107442 RWE to vacate an unopened portion of County road right-of-way (ROW) known as 136th St SW, located in Section 32, Township 28 North, Range 4 East, W.M. The County Engineer’s Report recommends vacation, provided the Petitioners pay for the costs and expenses associated with vacation.

A summary of the Ordinance is as follows:

ORDINANCE NO. 26-015

AN ORDINANCE VACATING AND ABANDONING AN UNOPENED PORTION OF  
136TH ST SW, A SNOHOMISH COUNTY ROAD RIGHT-OF-WAY

Section 1. Adopts Ordinance recitals as findings.

Section 2. Finds that the unopened portion of County road ROW is useless for County road purposes and that the public will benefit from its vacation.

Section 3. States that the unopened portion of County road ROW described in Exhibit A and depicted in Exhibit B is vacated upon satisfaction of the terms and conditions contained in the Ordinance.

Section 4. Conditions the vacation upon the Petitioners’ payment of itemized costs and expenses identified by the Department of Public Works (DPW) under Snohomish County Code 13.100.070 within one year of the adoption of the Ordinance.

Section 5. Exempts Petitioners from paying compensation for the vacated portion of 136th St SW because it is a Class D ROW under SCC 13.100.040(7)(d) where the County has an easement interest and no public expenditures have been made on the ROW.

Section 6. Retains a utility easement in favor of the County for utilities that are currently located within the ROW vacated by the Ordinance.

Section 7. States that the Ordinance shall be recorded and effective upon the Council Clerk receiving confirmation from the DPW that the Petitioners have met the conditions in the Ordinance for vacation. If the Petitioners fail to meet the required conditions within one year, the Ordinance will become void and have no further force or effect.
