PROPOSED ORDINANCE NO. 25-013
REENACTING AND AMENDING CHAPTER 7.54 SCC
PERTAINING TO INSPECTION AND MAINTENANCE OF
CONSTRUCTED STORMWATER CONTROL FACILITIES

Summary: The County's National Pollutant Discharge Elimination System (NPDES) Phase 1 permit Special Condition 55 C.10.b.i requires the County to have and implement ordinances or other enforceable documents requiring maintenance of privately-owned stormwater facilities that discharge to the County's municipal storm sewer. The County meets this requirement through implementation of Chapter 7.54 Snohomish County Code (SCC). Chapter 7.54 SCC will automatically repeal on April 20, 2025, unless reenacted prior to that date. Repeal of this code chapter would result in noncompliance with the NPDES municipal stormwater permit. The proposed ordinance would reenact Chapter 7.54 SCC with the sole change of repealing the sunset provision in 7.53.600.

At the Public Hearing, the Council may consider amendments to the proposed ordinance.
