PROPOSED ORDINANCE NO. 23-070
APPROVING APPLICATION AND AGREEMENT WITH THE STATE OF MINNESOTA FOR THE PURCHASE OF NALOXONE

<u>Summary:</u> The ordinance approves an agreement with the State of Minnesota to allow the purchase of naloxone through the Minnesota Multistate Contract Alliance for Pharmacy (MMCAP) Infuse organization. The Snohomish County Health Department partners with first responders, Tribal governments, police and fire departments, and community organizations to provide naloxone and train them how to use it correctly as they serve populations with opioid use disorder or individuals at risk of an opioid overdose.

<u>Proposed Amendment 1:</u> Add purchasing authority for naloxone in the amount up to \$250,000, and for purchases above \$250,000 to be approved by motion of the County Council.

At the Public Hearing, the Council may consider additional amendments to the proposed ordinance.
