The Respiratory Virus Hospitalization Surveillance Network (RESP-NET) is a key component of the EIP. RESP-NET comprises three platforms that conduct population-based surveillance for laboratory-confirmed hospitalizations associated with COVID-19, Influenza, and Respiratory Syncytial Virus (RSV) among children and adults. RESP-NET is a unique surveillance system because of the ability to conduct surveillance on

Background: Washington State Department of Health is one of the RESP-NET grant recipients from 1/1/2024 to 12/31/2028. Seven Local Health Jurisdictions (Benton-

Franklin, Clark, King, Snohomish, Spokane, Tacoma-Pierce, and Yakima) and one Health Board (Northwest Portland Area Indian Health Board) are subrecipients of the RESP-NET grant. These seven LHJs are also referred to as RESP-NET catchment areas that are representative of two geographic areas of Washington state, Western Washington or Puget Sound and Eastern Washington or east of the Cascade Mountain Range. There are 51 health facilities providing services for 5.7 million people that represent 73% of Washington state's population in the catchment areas. The population in the catchment areas includes tribal populations and cross-border populations near Portland, Oregon, and the Vancouver, Washington, metro area.
