<u>Authority Granted:</u> Ordinance 24-041 approves a service rate for 2025 and authorizes the Executive, or a designee, to negotiate interlocal agreement in substantially the same form as Exhibits A and B. Such agreements are subject to approval by Council by motion.

**Background:** In September 2018, Council passed Ordinance 18-046 approving the method for calculating EMS rates and a template ILA form for agreements through 2021, with the allowance for a three-year extension and annual rate adjustments. This ordinance established the 2019 fees per jurisdiction.

Snohomish County's Department of Emergency Management Services (DEM) is established in SCC 2.36.050<sup>1</sup> and operates as a local emergency management organization as provided for in RCW 38.52<sup>2</sup>. In that capacity, SCDEM provides support and coordination among participating agencies within Snohomish County for emergency management services through Interlocal agreements (ILAs).
