CALL TO ORDER

1. Ordinance 22-031, relating to funding the County Arts Program, setting maximum dollar amount for projects to be subject to 1% contribution to arts fund; amending Chapter 2.95 Snohomish County Code

Mr. Martin provided background on the Historic Preservation Commission and Cheri Ryan. He said if appointed, Ms. Ryan would serve as an at-large member and her term would expire January 2025.
