Snohomish County Ordinance No. 21-005 Background: This ordinance authorizes the Snohomish County Executive to sign the Interlocal Agreement Between the City of Lake Stevens, Snohomish County, and the Lake Stevens Sewer District Concerning the Southeast Interlocal Annexation and the Orderly Transition of Services Pursuant to RCW 35A.14.296.

A summary of the proposed ordinance is as follows:

PROPOSED ORDINANCE NO. 21-005

Section 1. Adopts recitals, findings, and conclusions.

Section 2. The Snohomish County Council authorizes the Snohomish County Executive to sign the Interlocal Agreement Between the City of Lake Stevens, Snohomish County, and the Lake Stevens Sewer District Concerning the Southeast Interlocal Annexation and the Orderly Transition of Services Pursuant to RCW 35A.14.296, a copy of which is attached to the ordinance as Exhibit A.

Exhibit A. The Agreement is summarized as follows: The Agreement provides for annexation of the SE Interlocal Annexation area and facilitates transition of services following the Annexation.

Amendment Sheet 1. The county council will consider amending the Agreement to insert May 28 as the effective date for the annexation, add a subsection to section 4 regarding ensuring minimum net residential density in the annexation area, and update references and section numbering. Note: these amendments are already reflected in the interlocal agreement under consideration by the city and the district.

The Interlocal Agreement will become effective after it is approved

by the governing bodies of the County, the City, and the District, and signed by their duly authorized representatives, and has either been filed with the County Auditor or posted on the County's Interlocal Agreements website. The Agreement (as would be amended by Amendment 1 to the county's ordinance) identifies May 28, 2021 as the effective date for the SE Interlocal Annexation.
